- Dig into your business idea! (Are there enough customers seeking what you offer? Who are your local competitors?)

Pre-Planning Process

- Develop a business plan.
- Determine the type of business entity you're operating. (e.g., Sole Proprietorship, LLC, Corporation)
- Decide on the location of your business. (Are you homebased, looking to lease or purchase?)

Establishing Your Business

- Register your business with the appropriate local and state government agencies. (e.g. Sole Prop or LLC, Fictitious Business Name, Tax & Employer Identification, etc.)
- Obtain business licenses, if relevant. (In Yuba County, only some businesses are required to have a business license.)
- Do you need startup funding or a loan? Have you established cash flow statements and financial projections? These friendly folks can help!
- Hiring and training employees.

Compliance & Operations:

- Ensure compliance with zoning regulations and land use ordinances.
- Obtaining permits and licenses for your business operations, including building renovations or signage.
- Familiarize yourself with tax filing deadlines and compliance requirements. Register for state and local taxes, including sales tax, payroll taxes, and business property taxes.
- Comply with health, safety, and environmental regulations specific to your industry.
- Understand federal, state, and local employment laws and regulations including minimum wage requirements, overtime regulations, and antidiscrimination laws.
- Obtain appropriate business insurance coverage, including general liability and workers' compensation, property insurance.

Continued Growth:

- Connect with local business organizations, events and community initiatives.
- Stay informed about changes in business tax regulations and labor laws.



NAVIGATING YUBA COUNTY

Community Development & Services Agency

ODSA includes many departments that work with businesses and manage land development. Read more about them below!

Planning

On every property there is an underlying land use designation (otherwise known as "zoning") set by the Yuba County Development Code. The Planning team is here to help you determine what type of business operations are allowed on your property, what type of signage can be installed, and if additional landscaping or screening is required.

Building

Once you've pinpointed your ideal spot, whether for a new build or tenant improvements, securing a Certificate of Occupancy is the next step to kickstart

operations. With various routes to this certificate, we're here to guide you in identifying the specific processes and submission documents tailored to your unique project.

Public Works

If you're considering alterations to your business site, additional permits from Public

Works may be necessary, including parcel maps, survey records, grading permits, and encroachment permits. You can also consult with Public Works when considering development in FEMA-designated floodplains.

Environmental Health

Depending on your business operations, you may need a permit from Environmental

Health. This includes, but isn't limited to, operations like gas stations, hazardous waste management, medical waste disposal, and food services, as well as tattoo and massage services.

County Clerk-Recorder

Here you can research property titles and register your Fictitious Business Name!

Agricultural Commissioner, Weights & Measures

Visit the Ag Commissioners Office to verify your scales or pumps, and obtain agricultural certifications, as needed.

Treasurer & Tax Collector

Head to the Treasurer & Tax Collector to obtain a Yuba County Business License (if needed) and for property tax payments.

Assessor's Office

The Assessor's Office appraises property values and business personal property (for example, equipment and machinery) for tax purposes. Visit the Assessor's office to report assessed personal property or research values of real property.
