

The Construction of A New Fishway And What It Means For Locals And Tourists Alike At Yuba River!

> The Yuba Water Agency has announced a comprehensive restoration project in the Yuba River for salmon and other threatened fish. The main actions include constructing a new fishway and modernizing the water diversion at Daguerre Point Dam to supply irrigation water and protect fish. A reintroduction program will support the recovery of spring-run Chinook salmon. The project will cost \$60 million, and is expected to be completed by the end of 2023.

> The project will be implemented immediately with the goal of reintroducing Chinook salmon in the North Yuba River by 2025. It is seen as an ambitious watershed restoration effort and one of the most comprehensive in California.

This is great news for visitors and locals! The modernized fishway allows you to float down the Yuba River and not have to get off at the Daguerre Point Dam. This means that you can enjoy the natural beauty of the river uninterrupted. The reintroduction program will revitalize the river ecosystem, making it an even more vibrant and thriving habitat for visitors to enjoy. The Yuba Water Agency is working hard to ensure that the Yuba River remains a scenic and sustainable part of the California landscape for generations to come.



REAR ELEVATION (NORTH)







STATE PROHOUSING DESIGNATION

- The County received the Prohousing Designation in April 2023 through a competitive program through the CA Housing and Community Development Dept.
- The Prohousing Designation Program provides incentives to cities and counties in the form of additional points or other preference in the scoring of competitive housing, community development, and infrastructure programs.
- The County was also awarded a Prohousing Incentive Pilot Program grant of **\$960,000** in June 2023; this program is designed to reward local governments with Prohousing Designation with additional funding to accelerate affordable housing production and preservation.

Industrial Real Estate:

Within the past 12 months the Airport has gained ownership and/or regained possession of a total of 5 buildings. While all are aged and in need of a maintenance plan, efforts are in place to secure job-creating, tax generating, and/or complimentary aviation related businesses in these valuable real estate assets.

Ultralight Operations:

The Corrective Action Plan, which included Standard Operating Procedures and a map showing the proposed location and required traffic patterns, was submitted to the FAA on June 7th. To date, no response has been received. The Airport is proactively working on preparing the proposed operating area in anticipation of FAA approval.
